Event parking will be available at the Kaanapali Golf Resort. Complimentary parking will also be available at Whaler's Village, 2435 Kaanapali Parkway.

TOURNAMENT RULES

This is a "tag and release" event for tilapias only. The tournament will begin at 8 a.m. and end at 9:30 a.m. marked by the sound of a horn. Prizes will be awarded for "Biggest Fish" and "Smallest Fish" categories. First - 3rd place prizes will be given for the Biggest Fish category, in each age division (ages 2-5, 6-12 & 13-18). For Smallest Fish category, only one prize will be awarded, in each age division. Fish will be measured by weight. In the event of a tie, check-in time will determine the winner. Must be present to win. Judges' decisions are final. In the interest of conservation, the tilapia must be kept alive.

- Participants must provide their own gear, to include: pole, hook, line, sinker, swivel, lead, bait, bucket & pump. Straight Poles **ONLY** (NO SPINNER POLES or POLES WITH REELS). Maximum length of pole is 10 feet. Maximum length of line should not exceed 12 feet.
- No nets will be used to catch fish or aid in the catching of fish.
- No diving in the pond to catch fish.
- No grabbing the fish out of the pond.
- The fish must be pole-caught in the KGR pond and alive to qualify for a prize. No mutilated tilapia will be counted.
- After fish are weighed, they will be released back to the pond in a timely manner by a tournament official.
- Participants will have a total of 1 ½ hours to fish to qualify for prizes.
- Fishing will take place on two sides of designated KGR pond, marked by a boundary marker. For safety reasons, no fishing on the bridge will be allowed.
- Child participants must have adult supervision at all times.
- Adults may *only* assist children with prepping the pole (hook, bait), bringing the fish in after it's been hooked, and/or removing the fish from its hook.



Please be considerate to those around you. As a reminder, no pets will be allowed on the course. No large tents, please. Enjoy and good luck in the tournament! Please keep this page for your information.

*Refreshments will be sold at the event as a benefit for Maui United Way. Due to sanitary reasons, it is advised not to eat/drink while handling fish. This is a non-alcoholic event.

This Release, Waiver, Assumption and Indemnity (this "Agreement") is made and entered by the undersigned in favor of Maui Electric Co., Ltd., Kaanapali Golf Course, their respective owners, administrators, officers, directors, members, managers, agents, employees and representatives, all event coordinators and officials, all sponsors, advertisers, and, if applicable, owners and lessors of premises used to conduct the event, their associates and affiliates, and volunteers who take part in this event (collectively, "Releasees").

In consideration of being allowed to participate in this event, known as the **2nd ANNUAL KEIKI TILAPIA FISHING TOURNAMENT 2010 BENEFITING MAUI UNITED WAY** (the "Event"), I, for myself, personal representatives, successors, assigns, heirs and next of kin (collectively, "I"), and for and on behalf of the child(ren) and/or ward identified on the front side of this document (individually and collectively, "Child"), to the extent that I am his/her parent or legal guardian:

1. Agree, acknowledge and understand that fishing can be a dangerous activity, and I, on behalf of my Child and myself, made a voluntary choice to participate in this Event despite the risks the activity presents.
2. Certify that my Child(ren) and I are each qualified, in good health and in proper physical condition, and possess the skill and experience necessary to participate in this Event, and understand that I will be solely and fully responsible for the supervision of myself and each Child at all times during the Event.
3. Acknowledge and understand that my Child(ren) and I will be engaging in activities that may involve the risk of serious injury, including paralysis, permanent disfigurement, disability, dismemberment and death, and severe social and economic loss which might result not only from actions, inactions, or negligence of myself, but also the actions, inactions or negligence of others, including the Releasees, or conditions of the pond or environment which are beyond the control of any person and risks not known to anyone or not reasonably foreseeable at this time.
4. Assume voluntarily all the foregoing risks and accept personal responsibility for damages following such injury described above.
5. **Release, waive, discharge and promise not to sue Releasees from any and all liabilities, claims, damages, costs, or losses, caused by any actions, inactions, or negligence of any person, including but not limited to any Releasee, myself or my Child(ren), to myself or my Child(ren), including death or damage to property, directly or indirectly, present or future, known or unknown, arising out of or related to our participation in the Event, and including any injury received or compounded by negligent rescue operations or procedures of Releasees. I further agree that if, despite this agreement, I or anyone on behalf of myself or my Child, makes a claim against any of the Releasees, I WILL IDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES from any expenses, attorney fees, damages, or costs which any may incur as the result of such claim.**
6. Consent to receive medical treatment which may be deemed advisable in the event of an injury, accident and/or illness to myself and/or my Child(ren), during the Event.
7. Agree to follow all rules, regulations, conditions and terms as set forth by Event officials. I will not do anything to degrade, embarrass, or cause harm to myself, my Child(ren), other participants of the Event, or the Releasees, and agree to conduct myself and my Child(ren) in a civil sportsmanlike manner before, during and after, and while in the vicinity of the Event, and that any uncivil or unsportsmanlike conduct will be cause for immediate disqualification from the Event at the discretion of the Event officials.
